CyberTech Total Revenue for Q2FY24 was Rs 583.5 million; up by 35.8% Y-o-Y basis

Mumbai, India – 27th **October 2023**: CyberTech Systems and Software Ltd. (BSE: 532173; NSE: CYBERTECH), a CMMI Level 3 next-generation spatial analytics and SAP digital solutions provider, announced today its financial results for the **second quarter and half year FY24** ended on 30th September 2023.












Revenue Metrics - Q2FY24
